All applications must be completed and returned to our Office by August 23, 2022. If you choose to return your application by mail, it must be postmarked by this date.

<u>FEE</u>: A **NON-REFUNDABLE** Processing Fee of \$40.00 must be submitted for each separately numbered examination for which you apply. A certified bank check or money order, made payable to: TOWN OF HEMPSTEAD. **NO CASH OR PERSONAL CHECKS WILL BE ACCEPTED**. SEE GENERAL INSTRUCTIONS FOR FURTHER DETAILS.

<u>FEE WAIVED</u>: Fees shall be waived for candidates who certify to this Commission that they are unemployed and primarily responsible for the support of a household, or receiving public assistance. Please obtain "Application Fee Waiver Request and Certification Form" from this Office. SEE GENERAL INSTRUCTIONS FOR FURTHER DETAILS.

SALARY: \$75,000 (2022) Present Town employees may be certified at a higher level than the announced salary.

<u>DUTIES</u>: Supervises subordinate planner personnel in the formulations, coordination, and presentation of planning studies, projects, research assignments, forecasts, and projections. Performs related duties as required.

MINIMUM QUALIFICATIONS:

- 1. (a) Bachelor's degree from an accredited college or university, with major coursework in Urban or Regional Planning, Architecture, Economics, Engineering, Community Development, or other appropriate major
 - (b) Seven years of satisfactory full-time, paid experience in local or regional planning, three of these years must have been in a supervisory or administrative capacity;

 OR
- 2. Satisfactory full-time, paid experience in local or regional planning (in addition to that specified in 1. (b), above) may be considered in lieu of a bachelor's degree on a two-for-one basis (two years of specified experience may be accepted in lieu of one full year of college). In order that this experience may be considered in place of college, a high school (or equivalency) diploma is minimally necessary;

 OR
- 3. Further formal (college-level) education with major coursework as indicated in 1. (a), above, may be substituted for experience on a year-for-year prorated basis, up to a maximum of one year (required experience waived) for a master's degree in one of the fields stipulated above.

<u>NECESSARY SPECIAL REQUIREMENT</u>: Possession of a current, valid Operator's License, issued by the New York State, Department of Motor Vehicles.

<u>RESIDENCY</u>: Unless otherwise specified, all candidates must be a resident of the Town of Hempstead for at least four months immediately preceding the date of the examination.

<u>VACANCIES</u>: The eligible list established as a result of this examination will be used to fill vacancies as they occur.

<u>SUBJECT OF EXAMINATION</u>: A written test designed to evaluate knowledge, skills and/or abilities in the following areas:

- 1. Preparing Written Material;
- 2. Sociological, Economic, Design and Environmental Factors involved in Land Use Planning and Community Development;
- 3. Principles and Practices of Urban Planning;
- 4. Collection, Analysis and Presentation of Data, including Basic Statistics;
- 5. Understanding and Interpretating Maps, Charts and Graphs;
- 6. Supervision.

The New York State Department of Civil Service has not prepared a test guide for this examination. However, candidates may find information in the publication "General Guide to Written Tests" helpful in preparing for this test. <u>NOTICE TO CANDIDATES</u>: Candidates are RECOMMENDED to use quiet, hand-held, solar or battery-powered calculators for this examination. Devices with typewriter keyboards, such as computers, spell-checkers, personal digital assistants, address books, language translators, dictionaries, cell phones, and any similar devices are prohibited.

<u>FINGERPRINTING</u>: A background investigation (fingerprinting check) may be required for appointment. Failure to meet the standards for the background investigation may result in disqualification. Pursuant to Chapter 548 of the laws of 1976, the Division of Criminal Justice Services requires each request for such search be accompanied by a fee. This fee must be submitted by the candidate. As of the date of this notice, the fee is \$75.00, plus an additional processing fee. The refusal of any candidate to submit the required fee shall in itself, disqualify a candidate from being placed on an eligible list for certification. You will be instructed at the appropriate time when and how to submit payment.

<u>DRUG TESTING</u>: Prior to appointment, you may be required to participate in a drug screening test. Candidates found to be abusing legal drugs or using illegal drugs will be disqualified.

This Commission reserves the right to limit the number of examinations, which may be taken by a candidate on a single test date.

If your application is deemed satisfactory, the Commission will notify you by mail of eligibility to take the examination. Exam admittance notice will accompany such notification. EXPANDED SCOPE DESCRIPTIONS:

- 1. **Preparing Written Material** These questions test for the ability to present information clearly and accurately, and to organize paragraphs logically and comprehensibly. For some questions, you will be given information in two or three sentences followed by four restatements of the information. You must then choose the best version. For other questions, you will be given paragraphs with their sentences out of order. You must then choose, from four suggestions, the best order for the sentences.
- 2. **Sociological, Economic, Design and Environmental Factors involved in Land Use Planning and Community Development** These questions test for knowledge of the fundamental concepts, design issues, terminology and practices utilized in the land use planning field, including how to best benefit the social, economic and environmental welfare of a community using appropriate planning principles.
- 3. **Principles and Practices of Urban Planning** These questions test for knowledge of the concepts and accepted practices involved in the land use planning and analysis of heavily-populated areas, and may include questions involving such areas as commercial and industrial development and redevelopment, transportation services, parking issues, zoning, landscaping, historic preservation and municipal revitalization.
- 4. **Collection, Analysis and Presentation of Data, including Basic Statistics** These questions test for knowledge of the proper procedures and methods used to gather, evaluate, organize, and utilize various types of technical data and information, and the fundamental concepts, terminology, and computations involved in statistical analysis.
- 5. **Understanding and Interpreting Maps, Charts and Graphs** These questions test for the ability to read and analyze visual and numerical information presented in maps, plans, and various types of graphic and tabular material, and to perform related basic computations. All the information needed to answer the questions will be provided in the maps, plans, charts, graphs, tables, or related written material.
- 6. **Supervision** These questions test for knowledge of the principles and practices employed in planning, organizing, and controlling the activities of a work unit toward predetermined objectives. The concepts covered, usually in a situational question format, include such topics as assigning and reviewing work; evaluating performance; maintaining work standards; motivating and developing subordinates; implementing procedural change; increasing efficiency; and dealing with problems of absenteeism, morale, and discipline.

<u>FEE WAIVER:</u> Amendment §50.5(b) of the Civil Service Law requires Municipal Commissions to waive application fees as stated on front of bulletin for candidates which meet this criteria. All claims for application fee waiver are subject to verification, and must be submitted with your application by the close of business on the application deadline as stated on the examination announcement.

NON-REFUNDABLE: A Processing Fee must be submitted for EACH separately numbered examination for which you apply. In writing for an application form or information, candidates should indicate the examination number and title of the position.

If education beyond high school is required for eligibility, official transcripts must be submitted. If transcripts were filed previously with the Civil Service Commission, a notation should be made on the application.

Candidates should be mentally and physically fit to perform the duties compatible with the position. Medical or physical examinations may be required.

All statements are subject to verification. Inquiries may be made as to character and qualifications.

A record of disrespect for the requirements and processes of law, including repeated traffic offenses or disregard of summonses for traffic offenses, is grounds for disqualification for examination, or after examination, for certification and appointment.

The Commission does not acknowledge receipt of applications. If an application is rejected, candidate will be notified and can appeal the decision by contacting this office. Candidates will be notified when and where to appear for examination.

When the written examination is prepared and rated by the New York State Department of Civil Service in accordance with Section 23-2 of the Civil Service Law, the provisions of the New York State Civil Service Rules and Regulations which deal with the rating of examinations will apply.

No one will be admitted to the examination site without the <u>official admittance notice and proof of identification in the form of a Photo I.D.</u>

Lists made up as a result of these tests will remain in force for at least one year and may be extended by the Commission not to exceed four years.

Changing circumstances occasionally result in certification and offers of employment under different conditions, such as higher or lower salaries, than those announced.

Vietnam Conflict - February 28, 1961 to and including May 7, 1975

Lebanon - June 1, 1983 to and including December 1, 1987

Grenada - October 23, 1983 to and including November 21, 1983

Panama - December 20, 1989 to and including January 31, 1990

Persian Gulf - August 2, 1990 to the end of such hostilities (not yet determined)

Commissioned corps of the US public health services: July 29, 1945 - September 2, 1945

June 26, 1950 - July 3, 1952

Credit for Lebanon, Grenada and Panama will be limited to those who received the Armed Forces expeditionary medal, the Navy expeditionary medal, or the Marine Corps expeditionary medal. The DD-214 form that has always been required to verify military service should also contain verification of possession of expeditionary medals for Lebanon, Grenada or Panama.

As of February 15, 1985 New York State Residency at the time of entry into active service is NO LONGER REQUIRED.

A disabled or non-disabled veteran who wishes to establish eligibility for additional credits MUST claim these credits with the filing of this application. You will be allowed the option of waiving these credits after the completion of the examination.
